Shannon noted the Welcome Home Program is a pilot program only available in rural communities during this phase. Shannon also gave an update on the development of a multifamily financing program. With respect to the Ag first-time farmer and rancher program, David Young presented staff's findings on how other states' Ag programs differ from NIFA's. David noted that NIFA will begin working with the legislature to amend the NIFA Act to increase the allowable net worth limit applicable to those eligible for the program to be more in line with the programs in neighboring states and anticipates bringing that and other proposed program revisions to the Board at the October meeting.
