Below is a request for public records pursuant to the Nebraska Public Records Act, Neb. Rev. Stat. §84-712 et sequentes. Pursuant to the same, please provide the following records, communications, correspondence and documents:

**REQUEST #1.** A copy of the executed LIHTC application submitted to the Nebraska Investment Finance Authority ("NIFA") by Foundations Development, LLC in 2019 or 2020 and related to 210 West Mission Avenue which was award credits at the February 21, 2020 NIFA Board meeting (the "Application"). It is possible the reference number for the Application is 7-0976.

**REQUEST #2.** A copy of any application for tax credits, whether funded or unfunded, submitted by Foundations Development, LLC to NIFA since January 1, 2018.

**REQUEST #3.** A copy of any application for tax credits, whether funded or unfunded, submitted by Robert Woodling to NIFA since January 1, 2018.

**REQUEST #4.** A copy of all emails, correspondence, documents, or the like related to the Application in Request #1, including all emails, correspondence, documents, or the like related to the award of credits based on the Application.

**REQUEST #5.** A copy of all emails, correspondence, documents, or the like between NIFA (including its Board of Directors, and any staff member or employee of NIFA) and Foundations Development, LLC from January 1, 2020, to the Present.

**REQUEST #6.** A copy of all emails, correspondence, documents, or the like between NIFA (including its Board of Directors, and any staff member or employee of NIFA) and Robert Woodling from January 1, 2020, to the Present.
